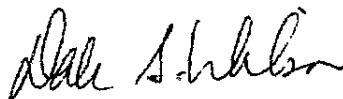

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit, under the laws of the State of Florida.

**ARTICLE I.**

The name of this Corporation is GCS STAGECOACH CO., INC.

**ARTICLE II. NATURE OF BUSINESS.**

The general character, purpose, and nature of business to be transacted by this Corporation is: day charter bus service and transportation of people within the State of Florida and any other business legally permitted under the laws of the state of Florida.

**ARTICLE III. CAPITOL STOCK.**

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any time is 1000 shares of common stock, each share having a par value of \$1.00. The initial street address of the principal office of this Corporation is to be at 2990 Ravines Road #1405, Middleburg, Florida 32068.

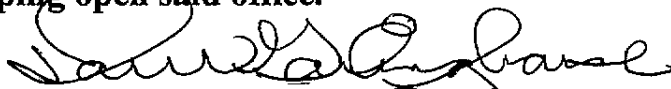
#### **ARTICLE VII. RESIDENT AGENT**
