ARTICLES OF INCORPORATION

OF

ARTICLE I

NAME

The name of the Corporation is "Dr. Jimmy, Inc.", and its principal place of business shall be located at 410 Jasmine Way, Clearwater, FL 33756.

The Shareholder reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment hereto.


ARTICLE XI**HEADINGS AND CAPTIONS**
