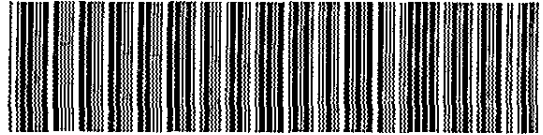

ARTICLE I - NAME

The name of this corporation is: **ADCANI'S EASY FURNITURE, INC.**

ARTICLE II - DURATION

This corporation shall have perpetual existence, unless sooner dissolved in accordance with the laws of the State of Florida.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of selling and trading furniture and household decorating items; furthermore, we will transact any other business permitted under the laws of the United States and of the State of Florida.
