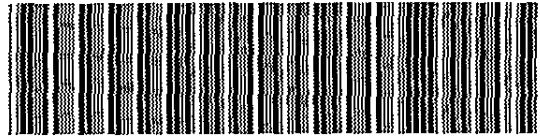

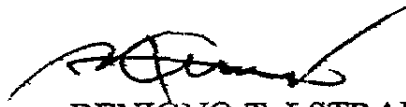

**ARTICLES OF INCORPORATION  
OF  
MR "B" AUTO REPAIRS & COLLISION SPECIALIST, INC.**

The undersigned incorporators for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following **ARTICLES OF INCORPORATION**.

**ARTICLE I  
NAME**

The name of the corporation shall be **MR "B" AUTO REPAIRS & COLLISION SPECIALIST, INC.**

**ARTICLE II  
PURPOSE**

The purpose for which the Corporation is organized is to transact any or all lawful business but not limited to auto repairs for which the corporation is organized under the Florida Business Corporation Act
