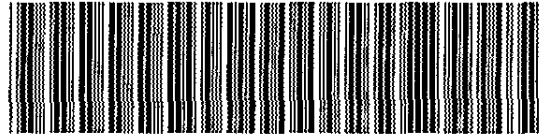

ARTICLES OF INCORPORATION
OF
ERIC'S EXTREME EXTERIORS, INC

The undersigned incorporator(s) for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

FIRST: The name of the corporation is ERIC'S EXTREME EXTERIORS, INC. (the "Corporation").

SECOND: The principal office address and mailing address of the Corporation is 1781 SW 13th Street, Boca Raton, FL 33486.

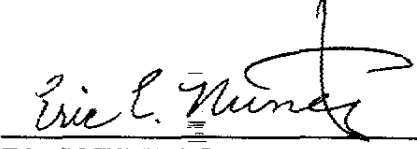
FIFTH: The name and address of the incorporator of the Corporation is ERIC NUNEZ, 1781 SW 13th Street, Boca Raton, FL 33486.
