THE UNDERSIGNED, for the purpose of forming a corporation for profit pursuant to Chapter 607, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I = NAME OF CORPORATION

The name of the corporation shall be:

ARTICLE II = GENERAL NATURE OF BUSINESS
