L, the undersigned incorporator, do hereby form a corporation for profit under the General Laws of the State of Florida, and pursuant to §607.0202, Florida Statutes, these articles of incorporation provide that:

ARTICLE I

The name of the corporation shall be MID KEYS ALUMINUM PRODUCTS, INC.

ARTICLE II

The location of the principal place of business shall be 9121 Overseas Highway, Marathon, FL 33050. The mailing address of this corporation shall be 9121 Overseas Highway, Marathon, FL 33050.

ARTICLE III

The corporation shall have perpetual existence.

ARTICLE IV

- 2. To generally engage in, do and perform any enterprise, act or vocation that a natural personal might or could do or perform.
