#### ARTICLE I - NAME

The name of this corporation is: LATIN AMERICAN GARDENS RESTAURANT, CORP.

## ARTICLE II - DURATION

This corporation is to exist perpetually. It shall commence its existence upon the signing of these Articles of Incorporation by the initial subscribers.

#### ARTICLE III - PURPOSE

This componation is organized for the purpose of transacting any and all business permitted under the laws of the United States of America and the laws of the State of Florida.

#### ARTICLE IV - CAPITAL STOCK

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which be already holds, shall have the right to purchase this pro ratashare thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.
