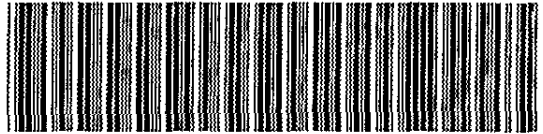



**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this Corporation shall be:

This Corporation shall have perpetual existence commencing
on 11/04/02.

ARTICLE III - PURPOSE


