The undersigned incorporator, RICHARD S. STRAZA, an individual authorized to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME

The name of this corporation is Rapid Disposal Services, Inc.

ARTICLE II - PRINCIPAL OFFICE
