

### CERTIFICATE OF INCORPORATION

#### ARTICLE I

ARTICLE X

Limitations of Corporate Stocks.

No shareholder of this Corporation may sell or transfer stock in this

Corporation except to another individual who is eligible to be an stockholder in the Corporation, and such sale or transfer may be made only after the same shall have been approved at a stockholder's meeting specially called for that purpose by not less than a majority of the outstanding stocks at such stockholder's meeting, exclusive of the stock to be sold. The stockholders voting at such meeting shall have first option to purchase the shares from the selling shareholder, the shares of stock held by the shareholder proposing to sell or transfer his shares may not be voted or counted for any purpose at said meeting.

#### ARTICLE XI


