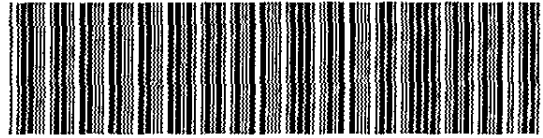

ARTICLE I - NAME

The name of the corporation is BARELY RIGGED ENTERPRISES, INC..

ARTICLE II - DURATION
