l, the undersigned, hereby execute the following document for the purpose of becoming a Corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liability, rights, privileges, and immunities of a Corporation For Profit.

# ARTICLE I NAME

The name of the Corporation shall be DICOSTA, INC.

# ARTICLE II DURATION

The Corporation shall have perpenual existence.

# ARTICLE III PURPOSE AND POWERS

The Corporation shall be entitled to engage in any and all lawful activities or business, permitted under the laws of the United States and of this State. This Corporation reserves the right, if it so wishes, to elect to be a 1361 Subchapter S Corporation under Section 1361 of the Internal Revenue Code and the right to elect to approve and adopt a plan to offer shares of common stock for sale under said section of the Internal Revenue Code and all other rights contained therein and may elect to receive all rights granted under any other Section of the Internal Revenue Service Code of 1954 as amended.

# ARTICLE IV CAPITAL STOCK

The aggregate number of shares which this Corporation shall have authority to issue is One Hundred (100) shares of Common Stock, having a par value of One Dollar (\$1.00) per share.

# ARTICLE V PRE-EMPTIVE RIGHTS


