ARTICLES OF INCORPORATION OF EIFFEL TOWER, INC.

ARTICLE I

The name of the Corporation is EIFFEL TOWER, INC.

ARTICLE II – DURATION

The Corporation shall have a perpetual existence.

<u>ARTICLE III – PURPOSE</u>

The purpose of this Corporation is for building and leasing communication towers and any other activities or business permitted under the Laws of the United States and Florida.
