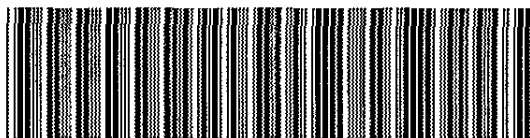



**ARTICLE I**

The name of the corporation shall be Knoy Services, Inc.

**ARTICLE II**
