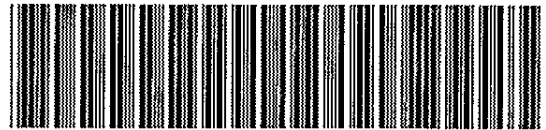

ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of OUR INTERNET, INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation is OUR INTERNET, INC.

ARTICLE II: ADDRESS
