

I, the undersigned incorporator, hereby make, acknowledge and file these Articles of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida.

### I. NAME

The name of the Corporation shall be Plant Depot, Inc.

# II. PURPOSE
