

## ARTICLES OF INCORPORATION OF SUNLESS TANNING EXPRESS, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopted the following Articles of Incorporation:

#### Article One - Name

The name of the corporation is SUNLESS TANNING EXPRESS, INC.

#### Article Two - Nature of Rusiness and Powers

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

#### Article Three - Term of Existence

The corporation shall have perpetual existence commencing upon the filing of these articles.

#### Article Four Capital Stock

## Article Five - Preferences, Limitations and Relative Rights of Shares of Capital Stock

#### Section | Dividends:

The holders of record of "Common Shares", if any, shall be entitled to cash dividends when and as declared by the Board of Directors at the rate per share per annum and at the time and in the manner determined by the Board of Directors.

#### Section 2. Rights upon Liquidation or Dissolution:

In the event of any voluntary or involuntary liquidation, dissolution or winding up of this corporation, after the payment of any and all debts and obligations, the remaining assets of this corporation shall be payable to and distributed ratably among the holders of record of the "Common Shares".

#### Section 3. Voting Riples:

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding "Common Shares".

## Article Six - Preemptive Rights

Every shareholder, upon the sale for each of any new stock of this corporation of the same kind, class, or series as that which he/she already holds, shall have the right to purchase his/her pro rata share thereof, at the price at which it is offered to others.

#### Article Floven - Amendment

This consent shall have the same effect as a unanimous vote at a shareholder's meeting.
