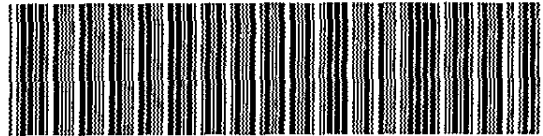

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

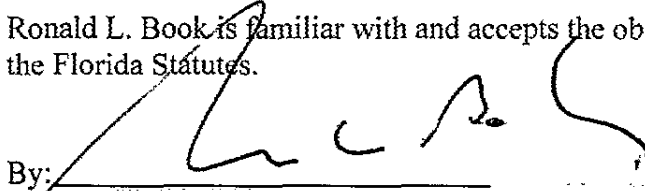
- FIRST: The name of the corporation is: SJE CONCEPTS, INC.
