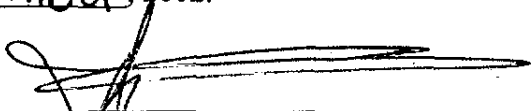
Article IX-Amendment to Articles of Incorporation

This corporation shall identify any officer or director, or any former officer or director, of this corporation to the fullest extent permitted by law.

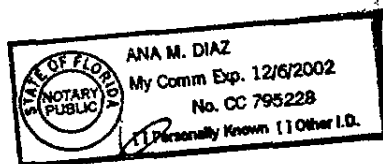

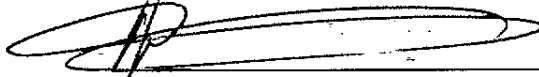

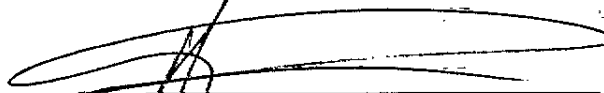
