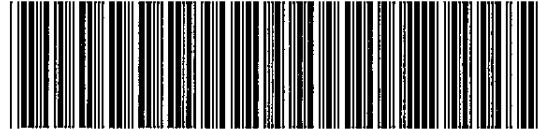

ARTICLES OF INCORPORATION AMNEEL, INC.

I
