

ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator of The Woods of Palm Beach, Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation is:
