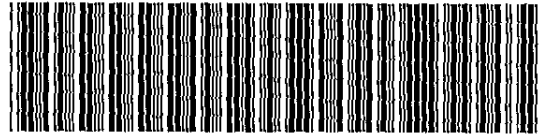

This is to certify that the undersigned do hereby associate as a body corporate for profit under the laws of the state of Florida, pursuant to the authority and provisions of Chapter 607 of the *Florida Statutes* and do hereby adopt the following Articles of Incorporation.

ARTICLE I.

Name

The name of the Corporation is HOUSECALL ACQUISITION CORPORATION. The Board of Directors shall determine the location of the principal office of the Corporation. Until such time, the principal office shall be maintained at 6501 Deane Hill Drive, Knoxville, TN 37919. The mailing address of the Corporation is 6501 Deane Hill Drive, Knoxville, TN 37919.

ARTICLE II.

Registered Agent and Registered Office

The registered office of the Corporation is located at 111 North Orlando Avenue, Winter Park, Florida 32789, and the name of the registered agent in charge thereof is T.L. Trimble.

ARTICLE III.

Purposes of Corporation

The purposes for which the Corporation is organized are to engage

in any or all lawful business for which corporations may be incorporated under the Florida Business Corporation Act, including, but not limited to, the performance of any and all acts or services that may be incidental or necessary to carry out such purposes.

ARTICLE IV.

Powers

The Corporation shall possess and exercise all the powers and privileges granted by Chapter 607 of the Florida Statutes, or by any other law of Florida, together with all powers necessary or convenient to the conduct, promotion or attainment of the activities or purposes of the Corporation, limited only by any restrictions set forth in these Articles of Incorporation.

ARTICLE V.

Term of Existence

The Corporation's existence shall commence on the filing of these Articles of Incorporation with the Secretary of State of Florida and shall thereafter continue in perpetuity.

ARTICLE VI.

Authorized Shares

SECTION 6.1 Number. The aggregate number of shares which the Corporation shall have the authority to issue is one class of one hundred (100) shares of Common Stock, no par value. Each share of Common Stock shall be entitled to the preferences, rights and limitations as specifically set forth in these Articles of Incorporation.

SECTION 6.2 Voting Rights. Each holder of record of Common Stock shall be entitled to one (1) vote for each share held at each meeting of the Shareholders with respect to any matter on which the Shareholders have the right to vote.

ARTICLE VII.

Preemptive Rights and Cumulative Voting

Shareholders shall have preemptive rights. Shareholders shall not be entitled to cumulative voting.
