ARTICLES OF INCORPORATION OF GOLD COAST CORES, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I - Name. The name of the Corporation shall be Gold Coast Cores, Inc.

ARTICLE II - Address. The address of the principal office of the corporation is 4251 NE 13 Avenue, l'ompano Beach, Florida 33064.

ARTICLE III - Purpose. The general purposes for which the corporation is organized are the following:

- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.
- C. To engage in sales and marketing of various kinds of industrial cleaners.

ARTICLE IV - Shares. The aggregate number of shares which the corporation is authorized to issue is one hundred (100) shares of common stock, such shares shall be of a single class and shall have a par value of \$1,00 per share.
