STATE OF FLORIDA ARTICLES OF INCORPORATION OF New Age Artwork, Inc.

The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I

The name of the Corporation is New Age Artwork, Inc.

ARTICLE II Principal Place of Business
