ARTICLES OF INCORPORATION
OF

I, the under signed, being of legal age, do hereby subscribe to, acknowledge and file the following Articles of incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be Juncal's Group, Inc. and initial address of this corporation shall be 9890 Caribbean Blvd., Miami, Florida 33189.

ARTICLE II

This corporation may engage in any activity or business permitted under the laws of the State of Florida and the United States of America.

ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stocks shall be as follows:

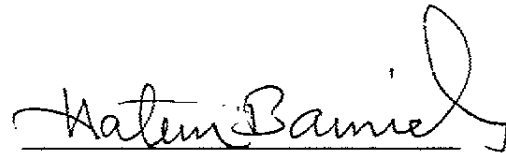
