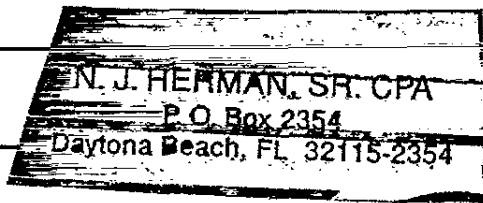

ARTICLES OF INCORPORATION
OF

The undersigned subscriber, being of natural person,
competent to contract for the purpose of forming a corporation
under the laws of the State of Florida, adopts the following
Articles of Incorporation for such corporation:

ARTICLE I

The name of the proposed corporation is

The purpose for which this corporation is organized is to

transaction of any or all lawful business for which corporations
may be incorporated.

The total number of shares of stock which the corporation shall have authority to issue is 1,000 shares of common stock, with a par value of \$1.00 per share.
