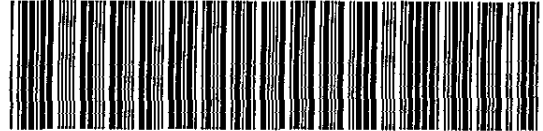

OF


ARTICLE VIII. PRIVATE PROPERTY


