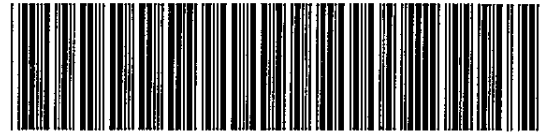

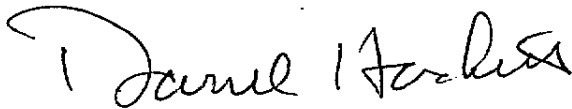

KNOW ALL MEN BY THESE PRESENTS: That the undersigned subscriber to these Articles of Incorporation being natural person competent to contract, hereby desire to form a corporation under the laws of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE I. NAME

The name of this corporation shall be: GREAT USED CARS, INC

ARTICLE II. GENERAL NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is to engage in the business of purchasing, improving, leasing, selling, mortgaging and investing in automobiles, trucks, and all motorized vehicles and personal property without limitation and all things related thereto and every legal business as permitted under the laws of the United States of America and the State of Florida.

ARTICLE III. CAPITAL STOCK

The amount of capital stock for this corporation shall be One Thousand (1000) shares of common stock having a nominal or par value of \$1.00 per share.

ARTICLE IV. TERM OF EXISTENCE

This corporation shall have perpetual existence unless sooner dissolved according to law.

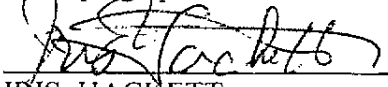
These Articles of Incorporation may be amended in the manner provided by law and approved by the shareholders by a majority of the stock entitled to vote thereon.
