We, the undersigned persons do hereby form the above corporation and to that end do hereby certify to the facts hereinafter set forth, as required by law.

I The name of the proposed corporation shall be: HARY OF THE DAYTONA FENCE, INC. II The general nature of the business to be transacted isoas

follows, to-wit:

1. Primary purpose will be to engage in the commercial and residential fence business and all related activities.
