The parties have no minor or dependent children in common, and the wife is not pregnant. The marriage between the parties is irretrievably broken. Therefore, the marriage between the parties is dissolved, and the parties are restored to the status of being single. Marital Settlement Agreement. [√one only] a. The parties have voluntarily entered into a Marital Settlement Agreement, and each has filed the required Financial Affidavit. Therefore, the Marital Settlement Agreement is filed as "Exhibit A" in this case and is ratified and made a part of this fine Hudement. The parties are ordered to obey all of its provisions. b. There is no marital property or marital debts to divide, as the parties previously have divided all of their personal property.
