I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

#### **ARTICLE I**

The name and initial address of this Corporation shall be: BCMG, INC., 214 Brazilian Avenue, Suite 220, Palm Beach, Florida 33480

#### **ARTICLE II**

This Corporation may engage in an $\overline{y}$  activity or business permitted under the laws of the State of Florida.

#### **ARTICLE III**

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:
