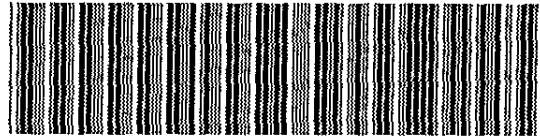

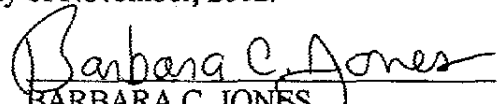
ARTICLE-IX- AMENDMENT OF BYLAWS
