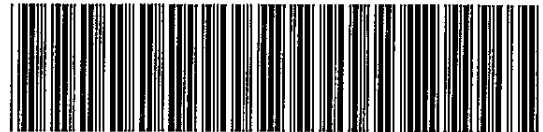

**ARTICLE I – NAME**

The name of the corporation shall be San Jose Group Incorporated.

**ARTICLE II – PRINCIPAL OFFICE**

**A. One Class of Stock**

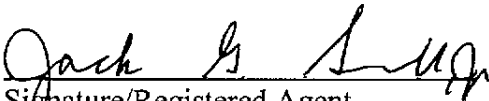
