The name of this corporation is: Mederi of Manatee County, Inc.

The corporation shall reimburse such persons for all costs, legal and other expenses reasonably incurred by her in connection with any claims or liability as to which it shall be adjudged that such officer or director is liable to the extent permitted by law.

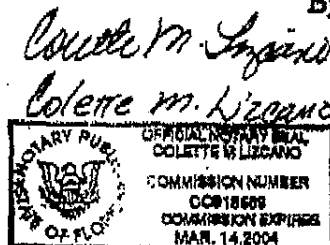
ARTICLE XIII
