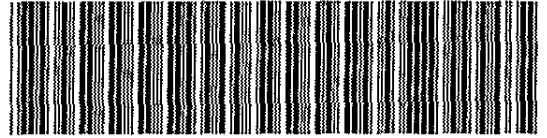



Article I  
Name

The name of the corporation is ALEX A. HANNA & ASSOCIATES, P.A., a Florida corporation.

Article II  
Duration

Effective Date  
11-08-02

This corporation shall have perpetual existence, unless dissolved and according to law, commencing on the 8 day of November, 2002.

Article III  
Purpose


Article VII
