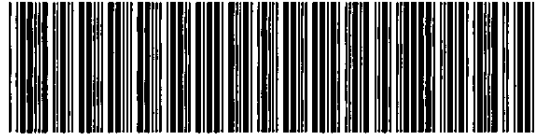

2. Article I. of the Corporation's Articles of Incorporation is deleted and replaced by new the Article I., as follows:

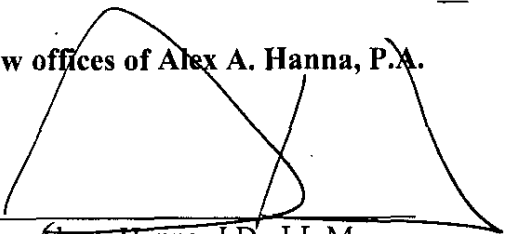
ARTICLE I.
