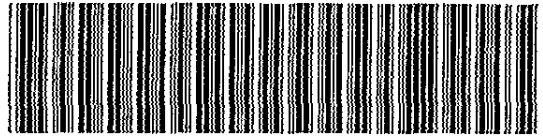



**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
ALEX A. HANNA & ASSOCIATES, P.A.**

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is ALEX A. HANNA & ASSOCIATES, P.A. (the "Corporation").
2. Article I. Of the Corporation's Articles of Incorporation is deleted and replaced by new Article I., as follows:


ARTICLE I.
