It appears that our registered agent, Mr. Ronald Lewis, Esquire of Belson & Lewis Law Firm, 2000 Glades Road, Suite 300, Boca Raton, FL 33431, had sent a letter (copy attached) to ask that the filing report be sent to us directly. We were unaware that he had requested a change of mailing address until just recently, however we never received the report at our office either so, we can only assume that your office did not make the correction or the address change request was somehow lost. Please note that at no time before the <u>late</u> UBR report was received by Mr. Lewis' office was there any <u>previous</u> notices received.

In the meantime, Mr. Lewis assumed you had corrected the address and mailed the UBR to our office and we thought Mr. Lewis' office, which takes care of all of our other legal affairs, was going to handle this for us since we were unaware of the address change request. Had he known that the adjustment had not been made he would have, most certainly, contacted your office to advise you that no notice was received.
