The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I
NAME

The name of the Corporation shall be: AC-Naples-Manager, Inc.

ARTICLE II
PRINCIPAL OFFICE

The principal place of business of the corporation shall be:

ARTICLE III
PURPOSE

The authorized capital stock of this Corporation shall consist of 1,000 shares of Common Stock with a par value of \$0.01 per share.
