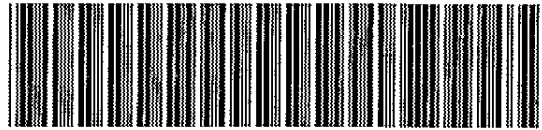

ARTICLES OF INCORPORATION
OF
JETT17, INC.

The undersigned, acting as Incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I-NAME

The name of the corporation shall be JETT17, INC.

ARTICLE II-PRINCIPAL OFFICE

The principal office of this Corporation shall be located at 5345 Lake Jessamine Drive, Orlando, Florida 32839.

ARTICLE III-DATE OF EXISTENCE

This corporation shall exist perpetually, commencing on the date of execution of these Articles of Incorporation.

ARTICLE IV-INDEMNIFICATION

This Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

ARTICLE V-STOCK RESTRICTION AGREEMENTS

Copies of any stock restriction agreement between this Corporation and its shareholders shall be maintained at the principal office of this Corporation.



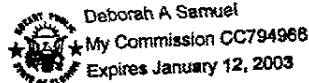

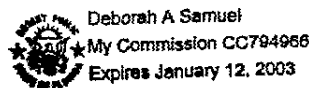
