### ARTICLES OF INCORPORATION

OF

LOOKING THROUGH YOU GLASS ART, INC.

## ARTICLE I - NAME:

The name of this corporation is: LOOKING THROUGH YOUR GLASS ART, INC., hereinafter referred to as the "Corporation" SARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.

### ARTICLE III - PURPOSE:

The Corporation is organized for the purpose of engaging in the Glass Art business and for the purpose of transacting any or all other lawful business not inconsistent with Laws of the State of Florida.
