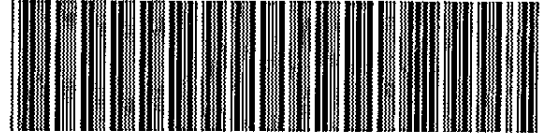

ARTICLES OF INCORPORATION OF SR 24 ENTERPRISES, INC.

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, file these Articles of Incorporation to form a corporation for profit under the laws of the State of Florida.

ARTICLE ONE: NAME

The name of this corporation shall be SR 24 ENTERPRISES, INC.

ARTICLE TWO: GENERAL PURPOSE

The purpose for which this corporation is organized is to engage in any lawful business under the laws of the State of Florida and the United States of America.

ARTICLE THREE: CAPITAL STOCK

The maximum number of shares of stock this corporation is authorized to have outstanding at any time is 100 shares of common stock.

ARTICLE FOUR: INITIAL CAPITAL

The amount of capital with which this corporation shall begin business is in excess of \$500.00.

ARTICLE FIVE: PERPETUAL EXISTENCE

This corporation shall have perpetual existence.

ARTICLE SIX: PRINCIPAL OFFICE; REGISTERED AGENT OFFICE AND ADDRESS

ARTICLE SEVEN: MANAGEMENT

The affairs of this corporation shall be managed by the Board of Directors consisting of not less than two persons and not more than fifteen persons, having a Chairman, a Secretary and a Treasurer (or a Secretary-Treasurer combined in one office). The Directors shall be composed of members of the corporation of such numbers as the corporation shall from time to time elect. The Directors shall be elected by the members of the corporation at the annual meeting, in such manner and for such term as shall be prescribed by the By-Laws of the corporation. The Directors shall each year immediately following the annual election elect a Chairman, a Secretary and Treasurer who shall hold office for a period of one year or until their successors are elected. Said officers shall have such duties as shall be prescribed by the By-Laws.

ARTICLE EIGHT: INCORPORATORS

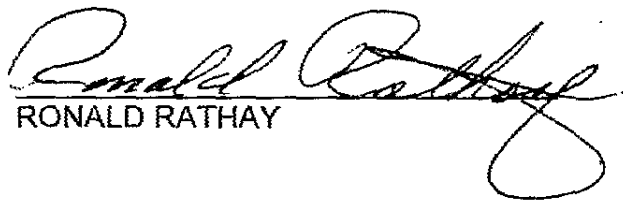
ARTICLE TEN: EFFECTIVE DATE

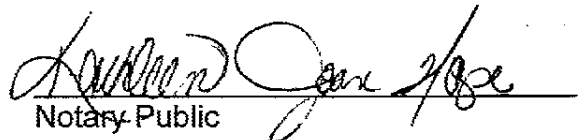
