

The undersigned incorporator hereby forms a corporation under the laws of the State of Mio.

Florida.

ARTICLE I NAME

The name of this corporation is LEMON STREET HOLDINGS, INC.

ARTICLE II ADDRESS

The corporation's address is 1516 Lemon Street, Tampa, Florida 33606.

ARTICLE III COMMENCEMENT OF CORPORATE EXISTENCE
