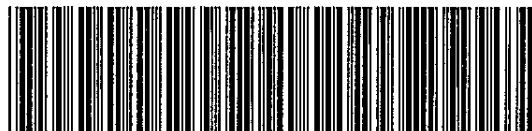

ARTICLES OF INCORPORATION

Of

Aroontida Incorporation

Article I. - Name

The name of this Corporation is Aroontida Incorporation

Article II. - Duration

This Corporation shall exist perpetually.

Article III. - Purpose

This Corporation is organized for the purpose of transactions of any or all lawful business or activities at any of its branches at one or more offices or agencies, both within and without the state of Florida, in any and all other states, territories and colonies of the United States, and in any and all foreign countries, subject to the laws of such state, district, territory, colony or country.

Article IV. - Capital Stock

The amount of paid in capital with which the Corporation will commence business is One hundred twenty Thousand and NO/100 (\$120,000.00) Dollars.

This Corporation is authorized to issue Twelve Hundred (1200) shares of Common Stock of One Hundred and NO/100 (\$100.00) Dollars per share which shall be designated Common Shares.

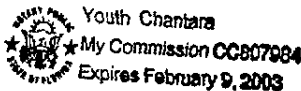
