The undersigned incorporator hereby executes, acknowledges and files with the Florida Department of State the following Articles of Incorporation (the "Articles") for the purpose of organizing a professional association under the Florida Business Corporation Act (the "Act").

ARTICLE I - Name

The name of the professional association is **SONIA WILCZEWSKI, P.A.**

ARTICLE II - Principal Office

The initial principal place of business or mailing address of the professional association shall be 888 Brickell Avenue, 5th Floor, Miami, Florida 33131.

ARTICLE III - Term of Existence

This professional association shall exist perpetually. Corporate existence shall commence on the date these Articles are executed and acknowledged, except that if they are not filed by the Department of State of the State of Florida within five days, exclusive of legal holidays, after they are executed and acknowledged, corporate existence shall commence upon filing by the Department of State.

ARTICLE IV - Nature of Business

This professional association is organized for the purpose of performing all duties of a law firm.

ARTICLE V - Initial Registered Office and Agent

ARTICLE VI - Directors

All corporate powers shall be exercised by and under the authority of, and the business and affairs of the professional association shall be managed under the direction of its board of directors. 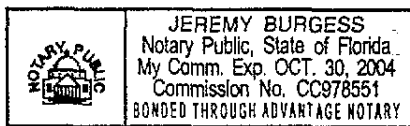




