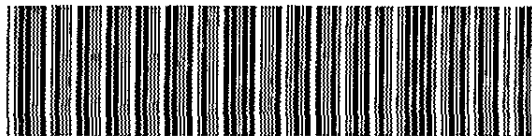

ARTICLE I - NAME

The name of this corporation is Elena Kolovrat, CMN, Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

ARTICLE IV - COMMENCEMENT OF CORPORATE BUSINESS


