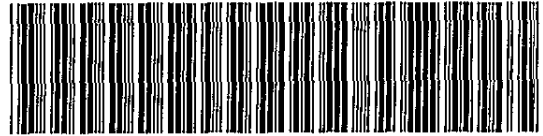

TOTAL COMPUTER WAREHOUSE, INC.**

The Name of the corporation is *Total Computer Warehouse, Inc.*

**ARTICLE TWO
DURATION**

This corporation shall commence existence as of the date of execution of these articles.
The term of existence shall be perpetual.

**ARTICLE THREE
PURPOSE**

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.
