ARTICLES OF INCORPORATION

OF

TWO BROTHERS BLOCK, INC.



The undersigned, in order to form a corporation for the purpose hereinafter stated, under and pursuant to the General Corporation Act of the State of Florida, do hereby certify as follows:

ARTICLE I - NAME

The name of this corporation is: TWO BROTHERS BLOCK, INC.

ARTICLE II - PURPOSE

The general nature of the business to be transacted by this corporation shall be:

- Primarily to engage in the construction business A) of block layers and in general to perform any duties that may be related thereto.
