### AMENDMENT TO THE ARTICLES OF INCORPORATION OF INDUSTRIAS INTERCAPS USA, INC.

The undersigned does hereby execute, acknowledge and file the following Amendment to the Articles of Incorporation of INDUSTRIAS INTERCAPS USA, INC.

- 1. The name of the Corporation is currently INDUSTRIAS INTERCAPS USA, INC.
